# POLICIES FOR PREPARING THE ANNUAL DISCLOSURE OF CRIMINAL STATISTICS

All incidents are reported and documented in the Incident Report, which is sent to the School Director. Reports are kept in a secure location in the administration office. The annual crime report is prepared by gathering campus crime statistics and data from the local police department and other relevant information by the institution.

# SECURITY AND ACCESS TO THE INSTITUTION

#### **ERIE CAMPUS**

# PROGRAMS TO INFORM STUDENTS AND EMPLOYEES ABOUT CAMPUS SECURITY

- New employees are trained in crime awareness, prevention, and security during hiring.
- Employees receive ongoing training during staff/faculty meetings.
- New students are instructed during orientation on security policies, prevention, evacuation plans, and reporting procedures.
- Students and employees are encouraged to take responsibility for themselves and others' security.

# PROGRAMS AND PROCEDURES REGARDING DOMESTIC VIOLENCE, DATING VIOLENCE, SEXUAL ASSAULT, AND STALKING

#### **ERIE CAMPUS**

#### **Definitions**

- Rape: penetration (no matter how slight) of vagina or anus, with any body part/object, or oral penetration by a sex organ of another, without consent.
- **Consent**: explicitly communicated, reversible, mutual agreement. Cannot be inferred from silence or lack of resistance. Incapacitation (alcohol, unconsciousness, under legal age, impairment) means no consent.
- **Domestic Violence**: violence by current/former spouse, intimate partner, cohabitant, shared-child partner, or others covered under family violence laws.
- **Dating Violence**: violence by someone in a romantic/intimate relationship with victim, evaluated by relationship length, type, frequency of interaction.
- Stalking: repeated conduct causing reasonable fear for safety or substantial emotional distress.

#### **Bystander Intervention**

Encourages safe interruption of harmful behavior (calling 911, texting a friend, using silent cues, staying aware of surroundings, etc.).

#### **Risk Reduction Strategies**

- Travel in groups / with a buddy.
- Use bystander techniques.
- Be aware of surroundings/alcohol.
- Carry rape whistle/pepper spray.
- Take self-defense classes.

#### **Programs**

- Primary prevention: education aimed at preventing violence (e.g., alcohol, drug abuse, anger management).
- Awareness programs: inform about violent crimes, bystander strategies, resources.
- Ongoing campaigns: regular updates and education from school, law enforcement, community.

#### **Victim Support**

· Recommended steps: go to safe place, preserve evidence, seek medical care, call for support.

- IMBC will assist victims in contacting law enforcement, accessing counseling/mental health, or adjusting classes to avoid assailant.
- Disciplinary action follows Student Conduct Policy; both accuser and accused may have support present and will be notified of final outcomes. Possible sanctions: warning, probation, suspension, dismissal.

#### PITTSBURGH CAMPUS

#### **Bystander Intervention**

Encourages safe interruption of harmful behavior (calling 911, texting a friend, using silent cues, staying aware of surroundings, etc.).

#### **Risk Reduction Strategies**

- Travel in groups / with a buddy.
- Use bystander techniques.
- Be aware of surroundings/alcohol.
- Carry rape whistle/pepper spray.
- Take self-defense classes.

#### **Programs**

- Primary prevention: alcohol, drug abuse, anger management programs.
- Awareness programs: violent crimes awareness, bystander intervention, resource information.
- Ongoing campaigns: continuing education efforts.

### **Victim Support**

- Recommended steps: safe place, preserve evidence, seek medical care, avoid being alone.
- Hotlines: PAAR (Pittsburgh Action Against Rape) 1-866-363-7273; Center for Victims Crisis Hotline 1-866-644-2882.
- IMBC will assist in contacting law enforcement, accessing counseling/mental health, or adjusting classes to avoid assailant.

- Disciplinary process: both accuser and accused can have support present, both notified of outcomes. Sanctions: warning, probation, suspension, dismissal.

# EMERGENCY RESPONSE AND EVACUATION PROCEDURES

- IMBC uses an **Emergency Notification System** to alert the campus community of any immediate threats. Notifications are sent by text, email, or phone.
- Content of messages is determined by the School Director, who confirms the type of emergency and which agencies to notify.
- Emergencies are immediately reportable to staff/faculty. Reporting to the School Director does not prevent anyone from also contacting 911.
- Annual tests of the Emergency Response system are conducted via text/email. Logs are kept, and surveys are distributed to measure effectiveness.
